- 2024 Gutter Project
 - It will cost \$26,000 to finish installing gutter guards on remaining homes (not including garaged)
 - This year we will spend \$4,500 to clean gutters.
 - We'll install gutter guards up to \$13,000 in 2024, and \$13,000 in 2025 to install the rest and complete the project.

Concrete, Asphalt, Railings

Walk through with Rose Paving and concrete contractor to review the 2024 projects.

- 10 catch basins and 20 infrared heat applications will be done this year. Under budget
- Prepared a 3 year plan for crack filling and seal coating
- 8 homes will have stoops/risers/walkways replaced this summer.
